- Our Short-Term Rehabilitation Units offer **FREE** cable television, Wi-Fi, and telephone.
- Our facility is open for family visitation. All visits must be pre-scheduled. Visitation is currently permitted in the main floor lounge area and our outdoor garden patio, 7 days per week. We hope to reopen visitation on the resident units soon.
- All Unvaccinated facility staff, physicians, and onsite medical contractors are COVID tested once per month, as per current New York State Department of Health regulations.
- Our facility has a full supply of Personal Protective Equipment (PPE) for a minimum of 60 days. This includes N-95s, facemasks, face shields, gloves and isolation gowns.
- Our facility staff are continuously trained on Infection Control Protocols and proper sanitation techniques. This is a **High Priority** for us in providing a very safe living and working environment for residents and staff.
- Residents are permitted to go out on a day pass into the community, accompanied by family members, according to current facility protocols.
- > Our facility has a full array of Recreational activities provided on all resident units 7 days per week.
- Our facility has multiple computer tablets that are utilized for Facetime /Virtual Visits with resident family/friends who are unable to visit onsite.
- Beautician and Barber services are available onsite weekly to meet the personal grooming needs of our residents.
